QUILT REGISTRATION PACKET for QUILTS OF VALOR® DONATIONS

We encourage all Ocean Waves quilters to create a quilt that will be donated to the Quilts of Valor Foundation program. "The mission of the Quilts of Valor Foundation is to cover Service Members and Veterans touched by war with comforting and healing Quilts of Valor." All Quilts of Valor (QOV) from the Ocean Waves Quilt Show have been awarded to Delaware Quilts of Valor and will be awarded to Service Members and Veterans at future award ceremonies. The donors or donating groups will be notified by email when their Quilts of Valor has been awarded.

PARAMETERS SPECIFIC TO QUILTS OF VALOR

- 1. Quilts of Valor quilts may be entered by a single quilter or as a group quilt.
- 2. Red, White and/or Blue are the preferred primary colors for Quilts of Valor. Please no military specific fabric should be used for the show quilts being donated.
- 3. Quilts of Valor must comply with the following size standards:

Ideal size is 60" x 80"

No smaller than 55" x 65" and no larger than 72" x 90"

- 4. 100% quality cotton should be used in the production of the quilt.
- 5. Use Cotton or 80/20 Blend batting
- 6. Quilts need to be machine pieced and quilted. Machine applique is acceptable, but NO embellishments are allowed.
- 7. Please use a double fold binding. The binding can be hand or machine finished.

DO NOT include a presentation pillowcase – We no longer use them.

DO NOT include a QOV label – we will attach an official QOV label when we prepare the quilt for awarding.

Entrants should email Marguerite or Dana once they have received their confirmation from the Quilt Show Registration committee to inform them that they will be donating their quilt to the Delaware Quilts of Valor.

- In planning the display of the QOVs, which Marguerite will be coordinating and
- To serve as a record of the quilts we will be receiving.

OCEAN WAVE QUILT SHOW INSTRUCTIONS - DONORS OF QUILTS OF VALOR NEED TO FOLLOW:

- 1. All entrants must submit a QOV Registration Form (for insurance purposes). There is NO fee for entering a QOV quilt **but if judged** a \$10 fee is required. The registration form is part of this packet.
- 2. Deadline for submitting registration forms is February 6, 2023.
- 3. Two 4" x 6" photos must accompany your registration forms.

- 4. Completed Forms may be submitted at guild meetings, mailed, or emailed.

 Put QOV REG in the subject line.
- 5. All entries must have a 4" sleeve for hanging. NOTE: Sleeves of quilts must be hand stitched to the back so they can be removed before presentation.
- 6. Bring your Quilt of Valor in a pillowcase. It will be returned to you at the end of show.
- 7. Quilts must be delivered on Tuesday, April 11, 2023 between 9:00 am 11:00 am at Sussex Academy in Georgetown, DE.

CONFIRMATION OF LIMITED LIABILITY INSURANCE COVERAGE
